## Membership Transfer Authorization

Water Service rights granted by Membership and other qualification hereby cease contingent upon further qualification of the Transferee in accordance with the policies of the WLWSC.

By execution hereof, the undersigned hereby acknowledges that the Membership Transfer complies with the terms of one of the following items (1) through (4), thereby qualifying for transfer of Membership in accordance with the laws of the State of Texas.

- 1) The Membership is transferred by will to a person related to the Transferor within the second degree by consanguinity; or
- 2) The Membership is transferred without compensation to a person related to the Transferor within the second degree by consanguinity; or
- 3) The Membership is transferred without compensation or by sale to the Corporation; or
- 4) The Membership is transferred as part of the conveyance of real estate from which the Membership arose.

Transferee understands that qualification of Membership is not binding on the Corporation and does not qualify Member for continued water service unless the following terms and conditions are met:

- 1) This Membership Transfer Authorization For is completed by the Transferor and Transferee;
- 2) The Transferee has completed the required Application Packet;
- 3) All indebtedness due the Corporation has been paid;
- 4) The Membership Certificate has been structured, properly endorsed, by the record Transferor;
- 5) The Transferee demonstrates satisfactory evidence of ownership of the property designated to receive service and from which the Membership originally arose; and
- 6) Any other terms and conditions of the Corporation's Tariff are properly met.

**Note: A Fee of \$100.00 is charged to the Transferee on all Transfers.**

Transferor may be due a refund of the Membership Fee,  
and Transferee understands that he/she must place on deposit a refundable Fee with the Corporation.

\$6.00	Per thousand from 10,001 to 20,000 gallons
\$7.00	Per thousand from 20,001 to 30,000 gallons
\$8.00	Per thousand from 30,001 gallons to 40,000 gallons
\$9.00	Per thousand from 40,001 to 50,000 gallons
\$17.00	Per thousand greater than 50,000 gallons

### Late Charge: \$10.00

If payment is not in our office or is not postmarked by the 15<sup>th</sup> of each month, the late charge will be added to your bill.

If your payment is not received, or if you have not notified us by the 25<sup>th</sup> of each month, your meter will be locked the 26<sup>th</sup> of the same month.

Cost to unlock the meter will be \$50.00, plus your current bill and late charge.
